How much solar energy does St Kitts use?

In St. Kitts and Nevis, the solar resource averages 5 kWh per square meter. Solar energy is already being used for grid-powered induction lighting and street lights along roadways. A 7 MW waste-to-energy power plant is planned to come online on St. Kitts in 2015.

Does St Kitts and Nevis have a national energy policy?

Yes, St. Kitts and Nevis has a National Energy Policy (NEP). The key provisions of this policy include connecting large-scale independent power providers and many distributed renewable energy systems to the electrical grid. Not all generation is made publically available; this chart provides known and referenceable data.

How much energy is lost in St Kitts & Nevis?

Reports indicate that in St. Kitts and Nevis, higher losses are largely attributable to nontechnical losses such as unmetered consumption, leading to losses that are higher than the U.S. Energy Information Administration's average transmission and distribution loss of 6%. By comparison, the U.S. Energy Information Administration reports an average transmission and distribution loss of 6%.

How much does electricity cost in St Kitts & Nevis?

The electricity rates in the Federation of St. Christopher (St. Kitts) and Nevis are \$0.26 per kilowatt-hour (kWh). This is lower than the Caribbean regional average of \$0.33/kWh.

How many MW of wind & geothermal will St Kitts have?

Short-term development plans include 5.4 MW of wind on St. Kitts and 10 MW of geothermal on Nevis. Additional 20 MW of wind, 5 MW of solar, and 35 MW of geothermal is planned.

What is the difference between St Kitts and Nevis?

The system losses in St. Kitts are about 17%, while Nevis has higher system losses of 20.3%. By comparison, the U.S. Energy Information Administration reports an average transmission and distribution loss of 6%.

In 2010, a 2.2 MW wind power plant, consisting of eight GEV MP 275/32 turbines rated at 275 kW each, was completed on Nevis. The island has now embarked on a very ambitious goal to achieve 60% renewable energy consumption by the year 2015. St.

Also interesting: Holiday resort in England self-supplies using solar power and storage. The PPA will enable significant cost savings of up to 40 per cent compared to the current cost of generating electricity, which St. Kitts mainly covers with diesel generators. The solar storage unit hybrid replace over 4 million gallons of diesel per year.

Most power on both islands is generated by diesel generators (95%) with 3.9% of wind and only 1.77% of solar. There are high power losses of 20% on Nevis and 17% on St Kitts suggesting maintenance problems. St Kitts has installed capacity of 43 mW and Nevis 13.4 mW but government has plans for a further 70 mW.

The government of St. Kitts and Nevis has hired battery storage firm Leclanché to build a large-scale solar-plus-storage facility that will cover a quarter of the twin-island nation's power needs.
