How much is ACWA Power worth?

ACWA Power's portfolio of projects in operation and development has an investment value of USD 85.7 billion, and a capacity of 55.1 GW of power and 8 million m³/day of desalinated water.

Who is the CEO of ACWA Power?

ACWA Power's board of directors is chaired by Mohammad Abdullah Abunayyan, with Raad Al Saady as its Vice Chairman and Managing Director, and Marco Arcellias as its CEO. In 2002, the Government of Saudi Arabia changed the regulations so that the private sector was permitted to own and operate utilities such as water and power plants.

How has ACWA Power changed the world?

ACWA Power has shifted from thermal desalination to SWRO, reduced the water tariffs by 58% and reduced the Specific Power Consumption required to desalinate per m³ of water by 87% in a decade. Green hydrogen and its derivatives are the new renewables.

How many people work at ACWA Power?

We employ more than 4,000 people, with ~60% local employment. ACWA Power's portfolio, with an investment value of USD 94 billion, can generate 65.6 GW of power and produce 8.0 million m³ /day of desalinated water.
