

Can foreign investments be expropriated in Uruguay?

Uruguay has not registered cases where foreign investments have been expropriated. In recent years, the country has been improving its property rights regulations for economic activities to promote private investments, especially from abroad. During the first decades of the 20th century, Uruguay became a state-centered capitalist economy.

Is Uruguay a reliable country for FDI?

As a result of being perceived as a reliable country, FDI grew during the decade from 2005 to 2015, and Uruguay obtained many benefits, including maintaining its investment grade status up to the present. These trends remain stable over time, regardless of the ideology of the ruling party.

What is the Gini coefficient in Uruguay?
