Why is Cameroon stepping up its renewable generation?

The government of Cameroon plans to step up its renewable generation to increase the rural electricity access rate, diversify the generation mix and achieve greater energy security as part of its NDC.

Who generates electricity in Cameroon?

Presently, electricity is generated by independent power producers (IPPs) and Energy of Cameroon (ENEO) (the latter also doubling as the sole distributor), to consumers over a transmission network managed by National Electricity Transmission Company (SONATREL).

Does Cameroon have a solar energy readiness?

Mas'ud et al. assessed the solar energy readiness in Cameroon by highlighting the irradiation pattern across the country. Abanda underscored that the mean solar irradiance is roughly 5.8 kWh/m²/day in the northern regions, while it's in the range of 4.0-4.9 kWh/m²/day in the southern regions of the Country.

Should Cameroon reassess its power sector masterplans?

The study also shows that higher renewable energy targets result in significant economic and emission savings compared to the Reference scenario. Therefore, Cameroon should reassess its power sector masterplans and intensify efforts to increase uptake of renewables.

Should Cameroon increase its electricity generation capacity?

These scenarios explore policy options and the economic costs of increasing the country's electricity generation requirements and reducing GHG emissions. Cameroon will require an eight-fold increase in its generation capacity between 2014 and 2045 to meet the 20% reserve margin target and general electricity requirements.

How much energy does Cameroon use?

In 2018, the total final energy consumption in Cameroon was 7.41 Mtoe, 74.22% of which was from biomass, 18.48% from fossil fuels and 7.30% from electricity.
