What is crossbridge energy?

This refinery supplies more than 35% of Denmark's entire consumption of liquid fuels for shipping, aircraft, cars, tractors and lorries. Crossbridge Energy considers energy efficiency to be an absolute top priority. The refinery in Fredericia is one of the world's most energy-efficient refineries.

Will crossbridge energy take over Fredericia refinery?

Crossbridge Energy A/S took over the refinery in Fredericia and its associated Trading & Supply activities as of 1 July 2021 and will be taking the refinery into a greener future. Crossbridge Energy A/S will continue the development of green hydrogen, advanced biofuels and co-processing.

Who owns crossbridge energy a/s?

Crossbridge Energy A/S is owned by Crossbridge Energy Partners, a US platform which seeks to play an active role in the green transition by transitioning traditional energy plants away from producing energy from fossil raw materials towards being based on green feedstocks.

What will crossbridge energy a/s do with everfuel?

Crossbridge Energy A/S will continue its collaboration with Everfuel to establish a 300 MW electrolysis and PtX plant next to the refinery, which will produce hydrogen from predominantly renewable energy in the refinery area.

How does crossbridge Energy distribute surplus heat?

Our surplus heat is distributed to more than 115,000 homes throughout the Triangle Region of Denmark via a partner. "Crossbridge Energy produces over 35% of all liquid fuels used in Denmark and has a corresponding export via our port terminal in Fredericia.
