Who owns Exterran Corporation?

Exterran Corporation was acquired by Enerflex Ltd. on October 13, 2022. Enerflex is a premier integrated global provider of energy infrastructure and energy transition solutions.

Who is Enerflex & Exterran?

CALGARY, Alberta and HOUSTON, Texas, Jan. 24, 2022 (GLOBE NEWSWIRE) -- Enerflex Ltd. ("Enerflex" or the "Company") (TSX: EFX) and Exterran Corporation ("Exterran") (NYSE:EXTN) today announced a business combination (the "Transaction") to create a premier integrated global provider of energy infrastructure.

Did Enerflex buy Exterran Corporation?

Enerflex Ltd. (TSX:EFX) completed the acquisition of Exterran Corporation (NYSE:EXTN) from a group of shareholders on October 13, 2022. Exterran Corporation's Equity Buyback announced on February 25, 2019, has expired.

What are the voting agreements between Enerflex and Exterran?

All of the directors and officers of Enerflex have entered into voting agreements with Exterran pursuant to which they have agreed to vote their respective Enerflex common shares in favour of the issuance of Enerflex common shares pursuant to the Transaction at the meeting of Enerflex shareholders.

How many shares of Enerflex will Exterran shareholders receive?

In accordance with the merger agreement, Exterran stockholders will receive 1.021 common shares of Enerflex for each share of Exterran common stock held. The trading of Exterran common stock is expected to be suspended today.

When was Exterran formed?

Exterran was formed when Universal Compression (1954) merged with Hanover (1990) in 2007. Universal Compression went public in 2000 and then acquired Weatherford, Global and Gas Compression Services, KCI, LCM and TCS. Hanover acquired APSI and POI to enter the gas processing business, and reorganized into GBU concept before the merger.
