The Chairman of the Czech Energy Regulatory Authority (ER&#218;) recently estimated the investment needed into the transmission and distribution system at 271 billion crowns (EUR10.7 billion) by 2030. Not all of that is directly related to the development of green energy, but it is an indication of the kind of money that will need to be found.

Rezolv aims to build a multi-gigawatt portfolio of wind, solar and energy storage.
