Will solar help Israel achieve energy independence?

The Israeli government is betting hard on solar and energy storage to help the nation towards energy independence. Energy minister Yuval Steinitz this week announced a new plan to deploy around 15 GW more solar capacity to help raise the 2030 target for the proportion of national electricity drawn from renewables from 17% to 30%.

Are photovoltaic solar panels available in Israel?
