Will the United States monitor North Korea's nuclear weapons program?

Who will monitor sanctions against North Korea?

SEOUL, Oct 16 (Reuters) - The United States, South Korea and Japan Wednesday announced the launch of a new multinational team to monitor the enforcement of sanctions against North Korea after Russia and China thwarted monitoring activities at the United Nations.

Why did the Security Council impose sanctions on North Korea?

The Security Council imposed sanctions after North Korea's first nuclear test explosion in 2006 and tightened them over the years in a total of 10 resolutions seeking -- so far unsuccessfully -- to cut funds and curb its nuclear and missile programs. The last sanctions resolution was adopted by the council in December 2017.

How much money is being used to fund North Korea's weapons development?

In its most recent report circulated last month, the panel of experts said it is investigating 58 suspected North Korean cyberattacks between 2017 and 2023 valued at approximately \$3 billion, with the money reportedly being used to help fund its weapons development. Are North Korea and Russia making illicit military transactions?

Washington and Seoul say North Korea and Russia have made illicit military transactions. Moscow and Pyongyang have denied arms transfers but have vowed to boost military ties, clinching a mutual defence treaty at a summit in June.

Will Russia and China continue to block sanctions against North Korea?

Thomas-Greenfield said it was clear that Russia and China, which abstained from voting on the U.N. resolution vetoed by Moscow, will continue to try to block international efforts to maintain monitoring of U.N. sanctions against North Korea.

The launches came days after North Korean leader Kim Jong Un supervised a flight test of the country's newest intercontinental ballistic missile designed to reach the U.S. mainland.
