Did Orix buy Greenko Energy Holdings?

ORIX acquired more than 20% of the shares of Greenko Energy Holdings, a major renewable energy operator in India, in March 2021 *2, while it acquired Gravis Capital Management Ltd. ("Gravis"), an alternative asset management company in the U.K. and active investor in the renewable energy sector, in January 2021 *3.

Who owns elawan energy?

European subsidiary ORIX Corporation Europe N.V. successfully gained regulatory approvals to acquire 80% of Elawan's issued shares, and becomes the majority shareholder in the business. Elawan develops and operates wind and solar power plants in 14 countries around the world, with a focus on Europe and North and South America.
