Innovation in Norway's energy sector is spearheaded by Enova, an entity owned by the Ministry of Climate and Environment. It supports new energy and climate technology in industry and transport, and the introduction of new technologies. The energy sent out by the plant when operating at 450 MW for 24 hours will be: $450 \text{ MW} \times 24 \text{ hrs} = 10,800 \text{ MWh}$. Plant Load Factor (PLF): $\frac{10,800 \text{ MWh}}{12,000 \text{ MWh}} = 0.9$ (90%) A low PLF is bad for the power plant as it indicates that the plant is not being used to its optimal capacity.
