How much do solar panels cost in Portugal?

In Portugal, the average cost per watt currently sits around EUR2.64. So, a typical 6 kW system (suitable for an average household) might cost around EUR15,840 before applying any grants. The government's SEAI grants can significantly reduce the upfront cost of solar panel installation.

Should I install a solar panel in Portugal?

It does not really compensate the investment. So you should only install the solar panel system based on your own consumption needs. It does make sense to install as well a battery.
