What is Resco solar?

The RESCO solar model is an energy service company that provides energy to consumers from renewable energy sources with an authentic concept- Users enjoy the benefits of solar energy without having to pay any upfront costs.

What is Resco solar financing?

In this solar financing model, a third-party service provider (RESCO) owns, installs, operates, and maintains the solar system on behalf of the customer. The RESCO model is often structured as a long-term agreement, typically ranging from 10 to 25 years.

How does Resco sell solar energy?

The RESCO model also sells solar energy through a Power Purchase Agreement (PPA). This is a long-term contract undertaken with the customer by the RESCO organization for 10 to 25 years. The customer's obligation in this scenario lies in buying electricity from the solar system at either fixed or variable prices.

Which Inverter should be used in Resco solar power plant?

Also, MPPT hybrid inverters shall be used, etc. Implementation Models and Financial Assistance: Under RESCO model, it is proposed that the vendor will install and operate the solar power plant of capacity up to 10 kWp for at least 10 years and solar PV plants of capacity above 10 kWp for at least 15 years.

What does a Resco developer do?

The RESCO developer takes responsibility for the annual operations and maintenance (O&M) of the Solar Power Plant. Any surplus power generated by the Solar Power Plant is sold to the DISCOM, benefitting the RESCO in terms of revenue from the excess energy sales.

What is the difference between CAPEX and Resco & OPEX solar?

Upon the transfer of ownership, the customer assumes responsibility for the operation and maintenance (O&M) of the solar project. The CAPEX model allows for savings to begin after the payback period, while in the RESCO/BOOT/OPEX model, savings commence from the first day.

Both the Central and State Government agencies give liberal and favourable laws for RESCO solar developers in order to fulfil their goal of 40GW of rooftop solar by 2022. RESCO model developers can get up to a 70% subsidy for RESCO projects on government buildings in a few special categories in some states.

RESCO developer finances, installs, operates and maintains the rooftop solar power plant. The developer signs an agreement with the rooftop owner. The rooftop owners may consume the electricity generated, for which they have to pay a pre-decided tariff to RESCO developer on a monthly basis for the tenure of the agreement.
