Which oil companies will lead Namibia's gas development plan?

Namibia's government has started talks with Shell (SHEL.L), Total (TTEF.PA), Galp (GALP.LS) and Norway's BW Energy (BWE.OL), and wants Namibia's national oil company Namcor lead the gas development plan. For the companies, the problem is the additional work could delay oil production into the 2030s, making it harder to monetise.

Can Namibia generate energy from renewable sources?

With ample sunshine and wind resources (on the coast), Namibia has the capability to generate significant energy from renewable sources.

Does Namibia have a solar power plant?

The government, the ECB, and NamPower have all expressed interest in grid-connected solar and wind renewable solutions, and in May 2015, Namibia inaugurated its first-ever solar power plant - a 4.5 MW plant - which represents one percent of the country's current production of energy.

Could a gas power plant be redesigned to supply Namibia & South Africa?

The idea is to revamp a long-stalled project to pipe gas to an onshore gas-fired power plant to supply Namibia, then neighbouring South Africa and the wider region. Initially designed to handle 1.3 tcf from Namibia's smaller Kudu field, the power plant project and related gas infrastructure would need significant upscaling.

Can Namibia become a net exporter of energy?

Over the long-term, the government and NamPower have committed to making Namibia energy self-sufficient (and eventually a net exporter of power) by building new domestic generation capacity. NamPower has made some progress in efforts to increase its generation capacity.

Why is Namibia not getting enough electricity?

Namibia's domestic electricity supply has failed to keep pace with rising demand, and Namibia generates less than half of the energy it consumes.
