Does St Kitts & Nevis offer a no-tax offshore domicile?

St. Kitts and Nevis offer a "no-tax" offshore domicile, which means that offshore companies and trusts not conducting business within the federation's territory are exempt from any tax obligations.

Can I start a business in St Kitts & Nevis?

In St. Kitts and Nevis, you can set up your business as a Limited Liability Company (LLC) or an International Business Company (IBC). An LLC is a popular choice because it offers protection from personal liability. This means if your company has problems with money, people who are owed money cannot take your personal things, like your house or car.

Are Nevis and St Kitts tainted by money laundering or tax evasion?

Neither Nevis nor St. Kitts have been tainted by reports of money laundering or tax evasion unlike a number of other offshore jurisdictions. A Nevis offshore company is exempt from taxation on income generated anywhere in the world outside of Nevis.

How do I register an offshore company in Saint Kitts?

Registering an offshore company in Saint Kitts can also be done in the form of a limited liability company (LLC). The particular requirements for LLC registration should be carefully considered when undertaking this process.
