R. J. Reynolds Nabisco, Inc., doing business as RJR Nabisco, was an American conglomerate, selling tobacco and food products, headquartered in the Calyon Building in Midtown Manhattan, New York City. R. J. Reynolds Nabisco stopped operating as a single entity in 1999.

RJR Nabisco Holdings Corp., despite a major diversification into food and other consumer products, still generates the majority of its sales and profits from its original business, tobacco. The company, one of the largest tobacco manufacturers in the United States, paid \$4.9 billion for Nabisco Brands in 1985.

What happened to RJR Nabisco?

In 1988 RJR Nabisco was purchased by Kohlberg Kravis Roberts & Co. in what was at the time the largest leveraged buyout in history. In 1999, due to concerns about tobacco lawsuit liabilities, the tobacco business was spun off into a separate company and RJR Nabisco was renamed Nabisco Holdings Corporation.

RJR Nabisco is a multinational corporation formed in 1985 through the merger of R.J. Reynolds Tobacco Company and Nabisco, Inc., which was known for its production of snack foods. This merger became one of the most notable events during the mergers and acquisitions wave of the 1980s, reflecting the aggressive corporate strategies of that era and the growing trend of ...

One year later, RJR Nabisco sold its Asia-Pacific businesses to Britannia Brands, a joint venture between BSN and an Indian partner. In 1991 RJR Nabisco went public again as RJR Nabisco Holdings Corp. Nabisco Foods Group scored a coup in 1993 when it introduced the Snackwells line of low-fat cookies and crackers.

RJR Nabisco, Inc. v. European Community, 579 U. S. 325, 335-336. Applying the presumption involves a two-step framework, which asks at step one whether the statute is extraterritorial.
