

What is Tajikistan e-visa?

The Tajikistan e-Visa is an online visa, implemented in 2016 by the Tajikistan Ministry of Foreign Affairs, to help facilitate the tourist visa handling process. The Tajikistan e-Visa can be issued as a single-entry or a multiple-entry (currently unavailable) visa.

Are exit visas available at airports in Tajikistan?

Exit visas are not available at airports in Tajikistan. Apply online for an e-visa from the Tajikistan Ministry of Foreign Affairs. Make sure you get the correct type of visa. Once you're in Tajikistan, you can apply for a visa extension at the Ministry of Foreign Affairs.

How to get a visa in Tajikistan?

Apply online for an e-visa from the Tajikistan Ministry of Foreign Affairs. Make sure you get the correct type of visa. Once you're in Tajikistan, you can apply for a visa extension at the Ministry of Foreign Affairs. You must have a transit visa to travel through Tajikistan on your way to another country. These are usually valid for 3 days.

What is Tajikistan's new visa system?

The new system is designed to facilitate the process of obtaining a visa to Tajikistan by foreign citizens, increase the number of tourists visiting Tajikistan, as well as to simplify visa procedures for businessmen. We also want to save time and relieve the personnel involved in the process of issuing visas.

How long is electronic visa valid in Tajikistan?

Electronic visa of the Republic of Tajikistan is valid for 90 days, however the visa holder can stay in the territory of the country for no more than 45 calendar days. Electronic visa is not extendable and the visa holder has to leave the country in the specified date.

How do I get an electronic visa in Tajikistan?

The Ministry of Foreign Affairs of the Republic of Tajikistan electronically processes and approves the electronic visa. To obtain an electronic visa, foreign citizens or stateless persons need to fill in and submit electronic application at , which is screened by the electronic information network automatically.
