The UK-based Gore Street Energy Storage Fund (GSF) has finalised a deal to acquire a 200MW construction-ready energy storage project from Kona Energy for an undisclosed sum. Located in Heysham, England, the project is claimed to be one of the largest energy storage facilities in Europe and is also GSF's largest acquisition to date.

This project aligns with Saudi Vision 2030's renewable energy goals. TotalEnergies also recently partnered with RWE to develop two offshore wind projects with a combined capacity of 4GW off the German coast. TotalEnergies will acquire a 50% equity stake in both projects from RWE, marking a significant collaboration in the renewable energy sector.

Octopus Energy Generation has completed the full acquisition of UK-based renewables and energy storage developer Exagen Group from its founder, Jeremy Littman. Exagen's development pipeline features more than 2.4GW of solar and energy storage initiatives throughout England.

RWE Clean Energy, a subsidiary of German utility RWE, has expanded its operations in the US with the acquisition of a 599MW portfolio of three solar and battery energy storage systems (BESS) projects. This move signifies an enhancement of RWE's renewable energy footprint in Idaho, Washington State and New York.

Norwegian energy company Scatec has signed a power purchase agreement (PPA) with the Egyptian Electricity Transmission Company for a 1GW solar and 100MW/200 megawatt hours (MWh) battery storage project in Egypt. The agreement, denominated in US dollars, extends for 25 years.

The investment will be channelled through Q-Energy V, one of Europe's largest renewable energy funds, valued at EUR2.4bn (\$2.7bn). In January 2024, Qualitas Energy acquired a wind project pipeline of 96MW in Germany. The move is expected to strengthen the presence of its subsidiary, Qualitas Energy Deutschland, in the country.

Norwegian energy firm Equinor has reached an agreement to acquire a 100% stake in East Point Energy, a US-based battery storage developer. Based in Charlottesville, Virginia, East Point Energy has a 4.1GW pipeline of mid-stage battery storage projects in the US East Coast region.

Other technologies, such as liquid air energy storage, compressed air energy storage and flow batteries, could also benefit from the scheme. Studies suggest that deploying 20GW of LDES could save the electricity system \$24bn between 2025 and 2050, potentially reducing household energy bills as reliance on costly natural gas decreases.

Kistos has announced the acquisition of EDF Energy (Gas Storage), which includes two onshore gas storage facilities in the UK, for a total consideration of \$25m (\$31.52m). This strategic move aligns with Kistos' focus on assets that support the energy transition.
