Jointly funded and developed by ENGIE and Eku Energy, the 150 MW/150 MWh Hazelwood BESS is Australia's largest privately funded utility-scale battery.

Who owns Hazelwood Bess?

Fluence supplied and will maintain the Hazelwood BESS under a 20-year contract with ENGIE and Eku Energy. Hazelwood BESS is the first project in Australia to use Fluence's Gridstack(TM) energy storage product.
